- Approved transport providers eg: Matthews Coaches\*

You also need to complete a separate application form on the Matthews Coaches website.

- Staff must complete an application form and send it with a digital picture to vpfca@dkit.ie
- DkIT will purchase the travel pass on your behalf and your salary will be deducted based on the duration of the ticket.
- If you leave your DkIT position before your agreement expires, the outstanding balance will be deducted from your final salary.
- DkIT accepts no liability or responsibility for lost travel passes. To replace lost travel passes, visit the Taxsaver website.
