Ms. Sinead Dunne requested that it be noted that the 2nd June leaves very little time for setup of programmes and will impact greatly on registration and timetabling for the following September.

The Registrar confirmed that this was discussed in great detail at the Programmatic Review steering group meetings, and that the timetable had been amended as much as possible and it was noted that additional personnel would be required.

Dr. Annaleigh Margey and Dr. Patricia Moriarty brought a proposal to Academic Council to remove the mathematics entry requirement to both the Level 7 Bachelor of Arts in Community Youth Work and Level 8 Bachelor of Arts (Hons) in Applied Youth Work (full-time and part-time modes). As this is a vocational programme, with modules aimed entirely at developing competent practitioners for the field of youth work, mathematics is not a prerequisite for study.

To date, mathematics has been a barrier to entry for many existing practitioners seeking to return to part-time study in youth work. Current, and future, students may also perceive it to be a barrier to their progression in the field. An analysis of competitor programmes also suggests that several have removed the mathematics entry requirement.

The current entry requirements for the programmes are the standard entry requirements for both Level 7 and Level 8 programmes.

In addition, all applicants must attend, and pass, an interview for entry to the programme, as a requirement of the endorsement body for youth work education, NSETS.

A discussion followed on the timeline for how soon the mathematics requirement could be removed from the CAO. Ms. Sinead Dunne, Admissions Officer to contact the CAO as the Department would like to see it implemented for September 2024.

These values are reflective of the nature and character of Geraldine and are aligned to the core values of a nursing graduate as specified by the HSE and NMBI.
