Each Head of School in turn presented the results from their School and acknowledged the work of their teams including Heads of Departments, Lecturers and Administrative Staff, the Registrar's Office and Examinations Office.

The Registrar commended the Examinations Office and added her thanks to Mr. Anthony Murray and his Team.

#### **Result Processing for the May 2024 Session**

Between the four Schools and the Examinations Office; results were processed for 5163 students from the 2023/2024 Spring Semester.

#### **Examination Overview May 2024 Session**

In the May Examination Session, a total of 3517 students sat 341 separate examinations over 8 days across 4 main venues primarily.

- A total of 172 students were facilitated with a smaller / separate room as part
  of their special need requirements with a further 29 sitting within a main
  venue.
- There was a 24% increase year on year in students requiring a separate venue.
- In total 65 invigilators managed the exams sessions.
- The examinations took place from 8th of May 20th May within a 9 day timeframe a reduction in 1 day from the previous year.

# Examination Spot-checks & Examination Infringements May 2024 Session

- Approximately 1000 spot checks were carried out during the examinations.
- Six students were found with prohibited material in the exam halls, and/or in breach of the regulations.
- Of these, one student was found to be in breach of Section 5, part 7 of the Regulations for the Conduct of Examinations, pertaining to mobile phones and electronic devices.
- Details of all breaches were forwarded to the Disciplinary Officer to be dealt with under the Student Code of Conduct.

#### Repeat for Honours / Exit Awards

Five students benefited from the repeat for honours process and 14 Exit Awards were processed in this session.

Members of Academic Council commended the committee on their work and agreed that a focused plan was now required. It was agreed that some of the more basic requested such as more microwaves for commuting students were not big-ticket items.

The President noted that the work being carried out across the campus during the summer months will resolved a number issues including the wi-fi. Dr. O'Callaghan noted that there are 400 additional car-parking spaces at DkIT-Sport with a regular shuttle bus and great spaces within the library for both meetings and quiet study. There are additional booths appearing throughout the Institute which could be promoted further.

It was noted that this discussion is linked to the Student Experience Strategy in the Institute's Action Plan. The President concluded the discussion with the promise that the full feedback from the working group could be discussed at the next Management Team Meeting in detail.

Dr. Sheila Flanagan, Vice President for Academic Affairs and Registrar outlined the background to this motion to the members of Academic Council. A series of meeting have been held to discuss the decision to re-categorise the research masters as a structure masters as the HEA provides an opportunity to allow structure masters for funding purposes.

Dr. Patricia Moriarty, Head of School of Business and Humanities added that this opportunity allows the Institute to run programmes at break-even points with such important funding. This practise is inline with the sector. Approval of this updated policy will allow greater freedom in the successful delivery of programmes. Dr. Breda Brennan suggested a minor change on page 17 to "structured masters only".

Dr. Annaleigh Margey presented a number of changes to the policies related to the Bachelor of Arts (Honours) in Social Care, including the Department of Humanities and Social Care Registration Programmes Policy on Student Attendance and Work Placement for Social Care-Common Policies and Procedures. These changes will allow for a stricter pre-placement training attendance and class/placement attendance requirement of 80%.

Dr. Margey carried out a survey of the sector and these changes are inline with other higher Education providers and meet all standards under CORU accreditation.

Dr. Brendan Ryder presented a new policy on Micro-credentials to Academic Council members.

- Micro-credentials are a record '...of the learning outcomes that a learner has acquired following a small volume of learning' (European Commission, 2022, p.13). They have the potential to offer increased flexibility and agility in responding to specific education and training needs (Carroll, et al., 2023). DkIT has seen increased demand for micro-credentials both from individual learners and from employers seeking to address skills needs for their organisations. In response, this policy will assist in the development of accredited existing and new learning pathways to form short, flexible learning experiences that are quality assured by the Institute, ensuring that learning is in line with skills needs.
- Micro-credentials can act as a mechanism for learners to update and diversify their skills
  portfolio flexibly and at their own pace, or for providers to expand their educational reach
  to disadvantaged or minority learner groups. For Higher Education Institutions (HEIs),
  micro-credentialling offers a novel and significant opportunity to augment educational
  offerings by drawing on existing programmes or developing entirely new ones. From a
  business perspective, it can also act as a new strategy for commercialising educational
  knowledge and expertise by diversifying educational packaging, delivery, and markets.
- The development and provision of micro-credentials is aligned with the DkIT Strategic Plan 2024-2028 (<a href="https://www.dkit.ie/strategicplan">https://www.dkit.ie/strategicplan</a>), specifically Strategic Pillar 3: Widening Access and Participation, Goal 3: To maintain a high-quality, inclusive and flexible student experience that supports all our students, holistically, and in their diversity, to achieve their potential.
- Micro-credentials offer a new opportunity to innovate and grow a HEI's programme portfolio while expanding their existing learner cohorts and reaching out to new and potentially under-served ones.

The following micro-credentialing strategies have been identified at DkIT for implementation:

- Existing Accredited Modules Strategy: Developing micro-credentials from existing
  validated programmes to offer "bite-sized" and flexible learning pathways and expand
  and widen access. Such micro-credentials could potentially be stackable toward the
  full award. Stackable micro-credentials can be combined towards a larger award.
- New Accredited Modules Strategy: Designing novel micro-credentials in areas that
  address current or future skills needs. This strategy might include developing short
  programmes in trending subject areas or modules that appeal to particular industry

sectors or new learner groups. Their primary intention is to upskill or cover urgent skills gaps. As such, these micro-credentials could be categorised as 'just in time' or 'on demand'. They may or may not be stackable.

Dr. Ryder recommended this this policy be adopted as a pilot for an initial 12 months and then reviewed. The policy was widely welcomed but a number of members had concerns regarding the less than 10 credits clause.

"The objective of this policy is to provide a quality assurance framework for the validation and certification of micro-credentials, units of learning that attract less than 10 ECTS credits."

A lengthy discussion took place on the need for flexibility in particular for the Peace Plus funding application and it was agreed to change the wording to "10 credits or less"

Further discussion was had on the difference between special purpose awards and microcredentials, the process for dealing new and existing modules, the role of the Programme Evaluation Sub-Committee (PEC), the format of the form in appendix 1 and what is required for operational and marketing purposes, the monitoring of the demand for such modules due to the resourcing and cost involved, the recording and management of records.

It was agreed to include a line in the policy under monitoring and periodic review on the role of the Programme Evaluation Sub-Committee (PEC) in the process.

# (D) Policy on Transfer and Progression

Ms. Sinead Dunne, Admissions Officer outlined the changes to the transfer and progression policy which will allow QQI applicants on a level 6 programme to be considered for years other then 2<sup>nd</sup> year.

These changes will allow for articulation agreements as the current policy allows for advanced entry into year 2 <u>only</u> and approval is now required to change to a 2+2 advanced entry.

Following a discussion, the following changes were agreed.

# **Under Advanced Entry 2.2**

- The normal entry requirement for admission to an add-on honours degree is a credit-weighted average mark of at least 50% changes to 40% in a cognate level 7 award, unless otherwise specified during programme validation. Non-EU candidates whose first language is not English, must have a score of IELTS 6.0 or equivalent. Students who have already completed undergraduate programmes or stages through English will be exempt from this requirement.
- Remove the text specified during validation- in sentence below

In the case of QQI-FET graduates, specific articulation arrangements, **specified during validation**- may be agreed for advanced entry to programmes.

## Under 3.2. Progression to Add-On Programmes within DkIT

 The normal entry requirement for admission to an add-on honours degree is a creditweighted average mark of at least 50% changes to 40% in a cognate level 7 award, unless otherwise specified during programme validation or explicitly approved by Academic Council.

The discussion concluded with an agreement that a communication needed to go out to Students.
