#### Standing Committee (AC:DOC:197:02:01)

Dr. Ronan Bree presented the minutes of Standing Committee. Dr. Bree highlighted that a rescinded award was dealt with at the last meeting. As this is new to the Institute, Academic Quality Sub-Committee will now examine and create a new policy.

#### Research Sub-Committee (AC:DOC:197:02:02)

Dr. Tim Mc Cormac presented the Research Sub-Committee Minutes to Academic Council.

#### Programme Evaluation Sub-Committee (AC:DOC:197:02:03)

Mr. Shane Hill presented minutes from the Programme Evaluation Sub-Committee.

#### Academic Quality Sub-Committee (AC:DOC:197:02:04)

Dr. Brendan Ryder presented two sets of minutes from the Academic Quality Sub-Committee to Academic Council. Significant work is been carried out on the Academic Integrity Policy with the establishment of two working groups to work on various aspects of updating the policy. Dr. Ryder indicated that Staff Feedback on DkIT's Guidance on Generative Artificial Intelligence needs to be analysed.

The Sub-Committee will examine a draft Rescinding and Surrendering of Awards Policy. The current DkIT Assessment and Standards includes a section for the revocation of an award. Based on recent experiences there is now a requirement to include the rescinding and surrendering of an award.

#### **Graduate Research Studies Board (AC:DOC:197:02:05)**

The minutes of the Graduate Research Studies Board were presented by Dr. Tim Mc Cormac. The Guidelines for PhD by Publication have been updated by DCU and adopted by DkIT. The "Declaration of Authorship Form" has also been updated and will be submitted to this committee for approval.

Year 2 Action plan emanating from the Self-Assessment Report through external quality was presented to the Board. The report was discussed by members with an emphasis on Year 2 actions. The Year 3 update to this report will be presented to DkIT GRSB at the end of this academic year.

Dr. Mc Cormac gave an update regarding the poor uptake of some online Epigeum Modules by the PGR community in particular the Research Method Toolkit. In addition, the chair informed the board that the Graduate Studies Office were currently procuring a new suite of online training platforms from Epigeum. The need for Viva Chair training was also emphasised and this will be run in semester 2 by the Graduate Studies Office.

Professor Fergal McCaffery presented two new programmes for approval. He highlighted that this was an interdepartmental blended programme which is both exciting and innovative and will add greatly to the School's Post Graduate offerings. He acknowledged the work of the Development Team lead by Dr. Adele Commins and the Registrar's Office.

#### (E) Consortium Agreement and Motion 197.05 - Deferred

# 197.5.1 Policies (AC:DOC:197:05:01)

Dr. Brendan Ryder outlined the context to the next three motions in relation to the Institute's position.

As part of briefing document (AC:DOC:197:05:01) he clarified that DkIT approved a "Micro-credentials Policy" through its Academic Council on the 20<sup>th</sup> June 2024, separate to the Policy on the Design and Approval of Programmes. A micro-credentials proposal form was also developed which was based on QQI's programme descriptor. Micro-credentials are either existing validated modules (validated as part of a programme validation) or new modules (requiring review by an external expert, similar to a standard module validation). A transcript of results for the modules taken is issued to students. The policy supports the piloting of Micro-credentials at DkIT for the academic year 2024/2025.

Dr. Ryder outlined the recently updated legislative and funding implication and acknowledged the significant work of THEA and the HEI Environmental Scanning that was carried out.

- For the purpose of validation by QQI, a micro-credential is a programme with the following attributes (DkIT adopted some of these characteristics in its current policy):
- volume of between 5 and 30 ECTS, leading to a special purpose award at NFQ 6 to 9.
- designed to meet a current market need for which there is demonstrable learner demand and value.
- targeted to a clearly expressed learner profile and programme delivery and assessment methods appropriate to that learner profile.
- delivered using a blended learning delivery mode (blend of onsite and online media) or solely online delivery. It will not be awarded transnationally.
- comprising one or more modules which may either originate from previously validated programmes or which may be novel.
- having a clear and persuasive rationale for creation of a new standalone award for such a programme rather than as an embedded award created through the standard validation / revalidation processes. These are standalone single programmes, without embedded awards. If additional award(s) is sought, this would require a separate application.
- with quality assurance procedures relevant to the delivery and assessment methods proposed.

# **Working Group Recommendation**

In light of the developments, DkIT policy and associated procedures should be updated to reflect the position as set out by Quality and Qualifications Ireland (QQI), which has been adopted by ATU.

Micro credentials should not be considered to be separate awards. The term should instead be used as an umbrella term to describe awards of 30 ECTS or less for marketing and communications purpose. The QQI definition should be adopted which would mean that the minimum ECTS value for a programme at DkIT would be 5 (lowering from 10 ECTS to 5 ECTS).

This would allow DkIT to meet its statutory requirement that, so far as is reasonably practicable, that each award that it makes is an award that is included within the Framework. Programmes published in the Irish Register of Qualifications (IRQ) are testament to the suitability of the existing NFQ policies and criteria for the inclusion of micro-credentials within the Framework.

We are also required to implement the Joint Sectoral Protocol and comply with all provisions in relation to awards standards, programme design and review, assessment and external examining, access, transfer and progression and credit, awarding and certifying qualifications and provision of information to learners.

It was noted that 5-10 credit modules can be validated as Special Purpose/Minor Awards and Microcredentials at the same time.

Mr. Anthony Murray, Examinations Officer presented a report on the recent examinations. Each Head of School in turn presented the results for ratification from their school and acknowledged the work of the Heads of Departments, Lecturing Staff, School Office Staff, Registrar's Department and the Examinations Office.

The Registrar congratulated Mr. Anthony Murray and his team on his successful completion of this suite of exams. Dr. O'Callaghan echoed his appreciation to all involved.

The Examinations Officer circulated a report on the result processing for the January 2025 session on the teams Channel.

#### **Result Processing for the January 2025 Session**

Between the four schools and the Examinations Office; results were processed for 4591 students from the 2024/2025 Winter Semester.

#### **Examination Overview January 2025 Session**

In the January Examination Session, a total of 3419 students sat 302 separate examinations over 8 days across 4 main venues primarily.

- A total of 182 students were facilitated with a smaller / separate room as part
  of their special need requirements with a further 37 sitting within a main
  venue.
- There was a 21% increase year on year in students requiring a separate (1-1) venue.
- In total 67 invigilators managed the examination sessions.

#### **Examination Spot-checks & Examination Infringements January 2025 Session**

- Approximately 700 spot checks were carried out during the examinations.
- 9 students were found with prohibited material in the exam halls, and/or in breach of the regulations.
- Of these, 5 students were found to be in breach of Section 5, part 7 of the Regulations for the Conduct of Examinations, pertaining to mobile phones and electronic devices. Details of all breaches were forwarded to the Disciplinary Officer to be dealt with under the Student Code of Conduct.
- The total amount of examinations that took place was in the region of 302.

#### 197.7.1 A.O.B.

A number of concerns relating to Carparks and Canteen Facilities were raised by Members of Academic Council. The President advised that Academic Council was not the forum and to bring it to the attention of Executive Board through the School Management Teams.
