The President walked members through the President's Report, drawing attention to the most pertinent aspects. Recent appointments were noted.

G316.5 Student Numbers & Recruitment Strategy

The Executive were invited to bring forward a presentation for discussion. The presentation predominately focused on student numbers and strategies to recruit students, including:

- CAO intake (new and cancelled programmes)
- Advanced entry strategy
- Retention strategies
- Part-time strategies
- Postgraduate pipeline
- Higher apprenticeship
- International students

Questions and Answers sessions were held after each member of the Executive presented. The following is a summary of some of the discussions: -

- The impact of local advertising and outreach campaigns.
- The profile of students by county of residence, including large feeder schools
- The cyclical nature of students interests which can be directly derived to current skill shortages and demands of the labour market.
- The impact of semesterisation and the challenges of semester 1 examinations for incoming students
- The change in student dynamics including macro-economic factors with many students now undertaking large amounts of part-time work.
- Experimental pedagogical techniques.
- Demand for level 7 programmes moving forward.
- Retention and the link between first choice CAO and retention rates.
- Impending Programmatic Review and changes to the programmes offering that may be implemented as part of this process.
- A niche carved out by the Institute in post graduate studies when historically IoTs were excluded from this market.
- Current funding calls that have been submitted to the HEA to progress initiatives such as apprentice development.
- Acknowledging different learning styles and embedding UDL in the curriculum.

The Chair thanked the Executive for an informative session acknowledging the sheer level of work underway across the Institute. The Chair also suggested the slides from today's presentation are included in the next meeting pack and brought up under matter arising, once members have had time to reflect on discussions today.
