WHAT IS THE EQUAL ACCESS SURVEY?

The Equal Access Survey is an annual, **voluntary** set of questions asked of first year full-time and part-time undergraduate students to Higher Education Authority (HEA)-funded institutions. The questions are asked as part of the registration process at the start of the academic year.

WHO CONDUCTS THE EQUAL ACCESS SURVEY?

The Equal Access Survey is conducted by your institution and data from the survey is returned to the HEA for analysis purposes¹.

WHY IS THE EQUAL ACCESS SURVEY CONDUCTED?

With information obtained from the Equal Access Survey, the HEA can **measure progress on national targets relating to equity of access to higher education and can develop the evidence base to inform policy in this area**.

WHAT INFORMATION IS COLLECTED?

To help progress the goal of equal access to higher education for all, information is gathered on the **disability, ethnicity (including members of the Irish Traveller and Roma communities), lone parenthood status** and commute time of students to higher education².

IS COMPLETING THE EQUAL ACCESS SURVEY MANDATORY?

While all students are encouraged to complete the Equal Access Survey, it is **not mandatory**. However, answering the survey questions will help in developing a better understanding of the student population and their needs. Non-response may have implications for the amount of State funding allocated to your institution.

CÉARD IS SUIRBHÉ AR **CHOTHROIME ROCHTANA ANN?**

Agus eolas ón Suirbhé ar Chothroime Rochtana acu, **is féidir leis an Údarás um Ard-Oideachas spriocanna náisiúnta maidir le cothroime rochtana ar ardoideachas a thomhas agus an bonn fianaise a fheabhsú chun cur le polasaithe sa réimse seo.**

CÉN EOLAS A BHAILÍTEAR?

Chun dul chun cinn a dhéanamh ar an aidhm cothroime rochtana ar ardoideachas do chách, bailítear eolas maidir **le míchumas, eitneacht (ina measc baill de phobal Taistealaithe na hÉireann agus den phobal Romach), stádas tuismitheora aonair** agus cé chomh fada is a thógann an turas do mhic léinn ar an ard-oideachas².

AN BHFUL AN SUIRBHÉ AR **CHOTHROIME ROCHTANA** ÉIGEANTACH?

Cé go spreagtar gach mac léinn uile chun an Suirbhé ar Chothroime Rochtana a líonadh, **níl sé éigeantach**.
