1. Strategic Planning Process

DkIT's Strategic Plan 201 7-2019 was approved by the Executive Board on 23rd January 2017 and by the Governing Body on 30th January 2017. The English and Irish versions of the Strategic Plan have been uploaded to the DkIT website. The Strategic Plan was launched through an all staff briefing at 2pm on Thursday, 16th March, 2017. Printed copies of the Strategic Plan were available for members.

2. Regional Development Centre

The RDC continues to be successful with the average occupancy in the RDC and Millmount Development Centre is 86% and 98% respectively.

New Frontiers Programme (NFP)

Sponsorship of $\in 12,000$ was received from AIB, PKF-FPM and Bridgewater to support the NFP Business Pitch competition for Phase 3 participants which took place on the 14th March.

Technology Transfer Office

DkIT submitted a nomination to the Knowledge Transfer Ireland Awards competition proposing Nova Leah Limited in the category of Spinout Company. A number of other licences were issued by the office, detailed in the report.

3. Lifelong Learning

Overall in 201 6/17 Part-time Whole Time Student Equivalent (WTE) numbers are at 198 up from 175 in 2015/16. The HEA call for Springboard 2017/18 has been published.

4. Public Accounts Committee (PAC)

The Public Accounts Committee invited the President and four colleagues to attend a meeting on Thursday 30th March to assist the Committee in its examination of the Financial Statements 2014/2015. The Chairman congratulated the President and the Team on the successful outcome at the meeting. No significant issues arose and it was felt that DkIT was well represented.

The President reported that she is travelling to Indonesia to sign an agreement with the Governor of East Kalimantan to provide scholarships to students to study at DkIT.

The president also reported that the person who had been successful in the competition for the Registrar post had turned down the position and a new competition will have to be organized.

Financial Report to 31st January 2017

The allocation for DkIT FOR 2017 is €16,540,330 (Reference correspondence no. 4) a 10.1% increase on 2016. The breakdown however is that €950,000 is allocated for pay awards (Reference correspondence no 2.) The remaining increase is based on the RGAM student numbers increasing and the increase in Apprentice blocks. The figures to the end of January 2017 show a small surplus and it is forecast, based on current information and given the increase in the allocation, that the Institute will break even again for 2017.0 This is to be closely monitored each month. It was noted, however, that the deficit of €3m still remains and will have to be dealt with.
