At 17.15 Ms. Irene McCausland, Vice President for Strategic Planning, Communications & Development and Dr. Pat McCloughan, PMCA Economic Consulting joined the meeting to discuss the following item.

G.248.5 DkIT AMBITION Consultation

The GB Chairman introduced Ms. McCausland and Dr. McCloughan to the Governing Body and asked the VP for Strategic Planning Communications & Development to give a brief background prior to the presentation commencing. A hardcopy of the presentation was circulated at the meeting.

Following the presentation there was a Q&A session:

The President stated that going forward the focus is on three principal areas:

• Increasing part-time industry provision programmes;

- Northern Ireland market. The Institute recently hosted a visit from 14 Principals based in NI.
- Ensuring that undergraduate and taught post graduate programmes are fit for purpose and the VP AAR to give a presentation at a future meeting.

Members commented as follows:

- Information provided was useful;
- Re-designation/Alliances;
 - Ground to be made up whether part of a TU or not;
 - DkIT unlike ITs in Dublin does not have a natural partner;
 - DkIT probably undersold, intend to address this in the future with the new Marketing unit.
 - Within the HUNT Report there are opportunities for Institutes on the Border. Unlike non-Border Institutes, DkIT could form an alliance in Northern Ireland with a University or other Colleges. DkIT currently actively advancing this.
- Funding
 - Currently students from NI are means tested, most avail of a loan scheme that students pay back after they commence work;
 - Not clear what the impact of Brexit will have;
 - The Department of Education & Skills currently treat students from NI as EU students;
 - The figures quoted in the presentation are as at 1st March (total population);
- Retention
 - Retention is extremely important and improved retention alone could substantially contribute to the targets proposed;
 - DkIT getting students enrolled in September but some may be gone by the 1st March;
 - Supports in the form of Centres of Excellence including Academic Writing should continue to be provided;
 - Most students don't differentiate between Institutes and Universities –" just go to college";
 - Focus on the students who come to DkIT why do they come to DkIT?;
 - Would like a report on the 5,000 students that attend DkIT, it's their voices we should be listening too, these are our strengths.
 - There is an ISSE survey conducted every year;
 - Need further investment and resources.

The GB Chairman thanked Ms. Irene McCausland and Dr. Pat McCloughan for his presentation and look forward to further update later in the year.

Ms. McCausland and Dr. McCloughan left the meeting at 18.30.
