G.251.2 Matters Arising

G.250.2 /G.249.2 "GB Gender Equality Sub-Committee Draft Terms of Reference"

The President noted that the Report that gave rise to the proposal is titled "Gender Equality in Irish Higher Education" hence the Draft Terms of Reference and proposed title reflected same. The President will take the suggestion on board from last month's meeting and change the proposed name to "Equality Sub-committee". It is always open to the sub-committee to revert to Governing Body with proposals to amend either the Terms of Reference or the title as they proceed with their work.

Ms. Antoinette Rourke referred to the recent launch of the "Accelerating Gender Equality in Irish Higher Education Institutions Gender Action Plan 2018/2020; Report of the Gender Equality Taskforce" and referenced page 33 i.e. "Governing Authority Gender Equality Sub-Committee - All HEIs to establish an EDI sub-committee of governing authority,"

The President proposed that the above title is broadened as he suggested and that the sub-committee when established could proceed as he outlined above.

Minutes of Meeting MF 179 dated 16th October 2018

Cllr. Tomas Sharkey sought clarification on MF.179.8 re disposal of the Ice Dome

Cllr Sharkey also enquired about lands that the GAA are interested in which will be discussed at a meeting of Louth County Council (3 landowners involved – Louth County Council, DkIT and ANO). The Acting Chairman, FAR, Chairman GB and the President stated Governing Body will be fully briefed on any discussions with the GAA. Both Cllr. Sharkey and Cllr. Tully emphasised that car parking facilities at DkIT Sport should remain under the remit of DkIT as they provide significant capacity for expansion.

Ms. Irene McCausland, Vice President of Strategic Planning, Communications and Development re-joined the meeting with colleagues from the Marketing Unit, Mr. Tom Redmond, Head of Marketing and Communications, Mr. Sean Egan, Webmaster and Ms. Natalie McGivern, Digital Content and Marketing Executive. Ms. Causland introduced the three members of the Marketing Unit. Following the introductions, Mr. Redmond presented an informative presentation including a marketing video to the Governing Body. There are two major events on in December $(11^{th} \& 12^{th})$ for Guidance Counsellors and Principals (North and South). After the presentation there was a Q&A session.

Louth to Fallstar Construction Limited under the Development Agreement re Schedule 11 of the Development Agreement re 1.75 hectares for a Nursing Home. Following a discussion it was proposed that the VPSCD contact our Legal Advisors to advise that it's stipulated the Governing Body are in agreement subject to the site remaining as per the Development Agreement 2005 in the Transfer of Lands legal documentation.
