#### **Declarations of Interest** Nil

### G.261.1 Property Matters – Louth GAA

The VP SCD informed the Governing Body the GAA have been in contact requesting a letter of consent for planning permission for the stadium. The VP SCD sought legal advice and tabled a draft letter at the meeting re: "Grant of Consent to Louth GAA County Board for the inclusion of three acres of land owned by Dundalk Institute of Technology and outlined in red the map appended hereto ("the lands") in its application for permission to Louth County Council" for discussion. The GAA want to apply to the Sports Council for funding to develop and they require planning permission.

### **G.261.3 Proposal re Regional Development Centre – Non Profit Company** The Chairman Governing Body checked with the Acting FAR Chairman in relation to the above item being discussed today as the FAR Committee didn't pass the recommendation for setting up a Non Profit Company.

Following a brief discussion, the Governing Body approved the setting up a Non Profit Company subject to the FAR committee approval. The Acting FAR Chairman suggested that notification is sent out to schedule a FAR meeting next Friday 9<sup>th</sup> August.
